## LVWGA GUIDELINES: SPECIAL GAMES/HOLE-IN-ONE REPRESENTATIVE

## **By-Laws:**

The Special Games/Hole-in-One Representative shall be responsible for determining the special game to be played for the year. She shall be responsible for maintaining a tracking record for participants going in special games and hole-in-one competition. Additionally, she shall disperse the money for both special games and hole-in-one games at the end of the year.

## **Responsibilities:**

- 1. The Special Games/Hole-in-One Representative will track activities of participants in the Special Games and Hole-in-One competitions throughout the year. She will be informed of participants by the Treasurer as fees are collected, and will disperse money at President's Day luncheon to Special Games and Hole-in-One winners.
- 2. The Special Game for the year is chosen by the Representative each year. It is a cumulative game kept throughout the year (March 1 November 30) and is optional for those playing golf. There is a \$5.00 cost (in addition to membership dues) to participate in Special games. They may include games such as Ringers (see below for explanation), Birdie Tree (competition between individuals of similar handicaps for the most birdies (or pars) during the year, or other games that might be considered. Ringers:
  - a) On the official play day, collect scorecards for each participant. Record the best score on each of the 18 holes beginning on March 1.
  - b) Prepare a spreadsheet for each golf course with each participating member's name and hole number.
  - c) These spreadsheets will be used for recording the improved score per hole on each official day of play.
  - d) After the first week of play (1st week in March), record the score for each hole that will be used as the baseline. On the following play days, only record the holes on which a player has improved her previous recorded score. The end of the competition is the last play day of November.
  - e) Results will be posted on the LVWGA bulletin board throughout the year.
- 3. Hole-In-One participation is optional for LVWGA members playing golf. There is a \$5.00 cost (in addition to membership dues) to participate. Hole-In-One participation is for a one-period (i.e., President's Day through the day before President's Day the following year). Participants must be signed up with the Representative and paid, prior to round to qualify. For additional guidelines, refer to LVWGA Standing Rule #18.
- 4. The Special Games/Hole-In-One Representative will be notified when any member achieves a hole-in-one on the LVGC and will present a pin to the player for her achievement.
- 5. The Special Games/Hole-In-One Representative shall attend all General Meetings and be prepared to report on any activity occurring within her area of responsibility. If

unable to attend the meeting, the Special Games-Hole-In-One Representative will inform the President prior to the meeting.

6. Any changes or questions regarding these Guidelines shall be referred to the President. These Guidelines will be updated on a yearly basis and sent to the President no later than November 1st of each year.
